



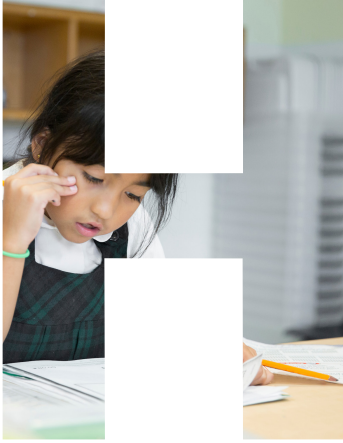
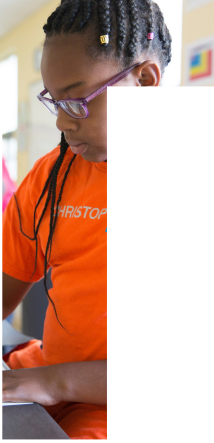

## ABOUT CHRISTOPHER HOUSE

Christopher House was founded in 1906 during the settlement house movement to support immigrants transitioning to life in America. The agency continually evolved to best meet the needs of the community and became a leader in piloting innovative programs such as Head Start in the 1960s and teen parent programs in the 1980s.

Today, Christopher House is **a family of schools in Belmont Cragin, Logan Square and Uptown that help more than 4,100 low-income, at-risk children and families** succeed in school, the workplace, and life.

Christopher House closes the opportunity gap for these individuals by providing **a personalized continuum of education, from birth through the eighth grade, paired with immersive family support**. We partner with families to provide education for our scholars and tools for parents to foster self-sufficiency, like food pantries, financial assistance, family workshops and home visiting programs.

We believe that every child, regardless of the circumstances they are born into, deserves a chance to thrive.
