Welcome, Presented by Dee Dee Chesley

Dee Dee welcomes all board members including Lauren Long, our newest member, and our two new parent representatives, Joel Lozado and Verenise Franco. Lauren, Joel and Verenise all introduce themselves.

Minutes, Motion was made by Adnan Assad, seconded by Ronit Barrett, and carried unanimously to approve the January Board Meeting Minutes.

Consent Agenda, Presented by Katheryn Steward

COVID-19 Response, Presented by Dee Dee Chesley

Dee Dee shared that the Leadership Team has been hosting a daily phone call to address the ongoing health crisis. The Leadership Team has put together a contingency planning document to organize responses to the ever-evolving situation and seeks the help of the Board in connecting the organization to legal or HR experts, given the need. Given the school closure, Christopher



House is moving to virtual services and has communicated with staff that they will be paid during the closure.

Annual Benefit Update, Presented by Meaghan Jennings

Meaghan reviewed the private philanthropy dashboard, which shows \$1.3 million of the \$2.4 million budget. To date, \$198,900 has been raised for the Annual Benefit, which was originally scheduled for April 30th. Meaghan presented the Board with the three options for the event: host a virtual event on April 30th, postpone to September or October 2020, or cancel altogether and host the event in 2021. Given the uncertainty of the health crisis, the Board agreed that the event should be cancelled to minimize costs. The External Affairs team will continue to focus on institutional giving, donor-advised funds and all Board members are reminded to make their personal financial commitments to the organization.
